Any disputes arising under or in connection with this MoU shall be resolved through mediation or another mutually agreed-upon method.



**Article 1: General Objective**

This Memorandum of Understanding shall provide the cooperation between the Parties in the fields of sports and youth development and excellence are to be jointly considered on the basis of reciprocity and mutual benefit. The parties shall endeavor to encourage and facilitate, as appropriate, the advancement of linkages and cooperation between and through the agencies that pertain to the fields of sports and youth affairs and shall endeavor to conclude such arrangements, for the conducting of cooperative activities and programmes in these fields.

**Article 2: Fields of Cooperation**

- a) Exchange of experts, officials, coaches, and athletes in the areas of sports,
- b) Training and competition of athletes and athletic teams,
- c) Training and technical assistance for players,
- d) Exchange programmes and visits of sports administrators, professionals, and sports support personnel,
- e) Training, exchange and attachment programmes for sports players and other development assistance in sports,
- f) Any other fields or subjects as deemed fit and necessary for the mutual benefit of the Parties, within the framework provided under this Memorandum of Understanding.



### Article 3: Amendments

This Memorandum of Understanding may be amended by mutual consent in writing between the parties.

### Article 4: Settlement of Disputes

Any dispute between the two parties arising out of the interpretation or implementation of this Memorandum of Understanding will be settled amicably by mutual consultation and negotiation.

### Article 5: Effect and Termination



#### 1. Arrangement of Life Management Workshop :-


Sessions will be arranged for Stress management, time management etc. Activities can be arranged in the premises of both the institutes.



## **1. PURPOSE OF THE MoU**

### **2.3 Sports Activities**

- Joint organization of sports events, tournaments, and physical education activities
- Participation of students and staff in inter-institutional sports competitions
- Sharing of sports facilities and coaching resources, subject to availability

### **2.4 Infrastructure Sharing**

- Mutual use of infrastructure including libraries, laboratories, seminar halls, auditoriums, ICT facilities, and sports infrastructure
- Sharing of academic and research resources as per institutional rules

## **3. IMPLEMENTATION**

- Both institutions shall appoint a Nodal Officer/Coordinator for effective implementation
- Activities shall be undertaken with mutual consent and as per institutional policies

#### 4. FINANCIAL ARRANGEMENTS

- This MoU does not imply any financial obligation on either institution
- Financial matters, if any, shall be decided separately with mutual consent

#### 5. CONFIDENTIALITY

- Both parties agree to maintain confidentiality of shared academic and institutional information unless disclosure is required by law.

#### 6. DURATION

- This MoU shall remain valid for a period of Three (03) Years from the date of signing
- It may be renewed with mutual written consent

#### 7. AMENDMENT AND TERMINATION

- Amendments may be made with mutual written consent
- Either party may terminate the MoU by giving three (03) months' written notice

#### 8. LEGAL STATUS


